

TERMS AND CONDITIONS

GOURMET PAWPRINTS Tours and Events

1. Definitions

1.1. Participant

- 1.1.1. The person/s named in the booking form or in attendance at an event
- 1.1.2. The Participant is deemed to have accepted and agreed to be bound by the terms and conditions outlined below.

1.2. Tour/Event

- 1.2.1. Refers to any Tour or Event organised by Gourmet Pawprints, such as but not limited to the following;
 - 1.2.1.1. Doggy Winery Tour
 - 1.2.1.2. Cinema/Music/Social Event
 - 1.2.1.3. Overnight/Weekend Tour
 - 1.2.1.4. Private Tours or Events

1.3. Injury

- 1.3.1. Refers to any loss, damage, illness, harm or death

1.4. Dog

- 1.4.1. Refers to any dog either participating in the Tour/Event or any dog in a public place which is visited during the Tour

1.5. Private Tour/Event

- 1.5.1. A Tour/Event organised by Gourmet Pawprints for a specific group of people. For example for a dog breed club or similar breeder group, corporate group, obedience club, charity event, birthday party or any other private event

1.6. Gift Voucher

- 1.6.1. Refers to a voucher purchased to be redeemed on a Public Tour or Event

2. Introduction

2.1. The Participant;

- 2.1.1. releases and indemnifies Gourmet Pawprints, its employees, contractors, agents and representatives against any and all claims or actions of any kind arising from any Injury sustained by the Dog or inflicted by the Dog upon any other dog or human s throughout the duration of the Tour/Event, and the Participant shall be responsible for all damages and costs incurred as a result of any Injury
- 2.1.2. acknowledges that transport for the duration of the Tour/Event maybe provided by bus, and the Participant acknowledges and accepts the inherent risk of injury and spread of illness between dogs as a result of the transportation of dogs in close proximity to each other.
- 2.1.3. releases and indemnifies Gourmet Pawprints against all liability resulting from any accident, injury or illness sustained by any dog or human as a result of the transportation of the dogs in close proximity to each other.

- 2.1.4. Is 18 years of age or over and can provide suitable identification if requested

3. Dog

- 3.1. The Participant warrants that the Dog:
 - 3.1.1. booked on the Tour/Event is in good physical health and is up to date on all worming, flea treatment and vaccinations, and the Participant undertakes to provide a copy of the Dog's current C5 vaccination certificate and sterilisation certificate upon request by Gourmet Pawprints.
 - 3.1.2. The participants undertakes to advise Gourmet Pawprints of any medical condition, medication or treatment of the dog
 - 3.1.3. Is wearing a flat collar with identification details attached
 - 3.1.4. Is not wearing a retractable lead
 - 3.1.5. is not suffering from any contagious illness, such as kennel cough, and has not displayed any symptoms of a contagious illness in the 21 days prior to the Tour.
 - 3.1.6. does not have a history of behavioural problems or aggression that may pose a risk to other dogs or humans.
 - 3.1.7. subject to clause 6.0, the Dog is de sexed
 - 3.1.8. is well socialised and able to cope in close proximity to other dogs and humans for extended periods of time
- 3.2. The participant acknowledges that dogs must remain outside at most venues.

4. Public Tours and Events

- 4.1. Gourmet Pawprints will advise guests if the tour is cancelled 18 hours prior to the departure time. Gourmet Pawprints will offer a transfer to an alternative date.
- 4.2. Gourmet Pawprints reserve the right to change the destination or reschedule any Tour/Event if due to circumstances beyond Gourmet Pawprints control, such as bushfire or flood, it be unsafe or impracticable for the Tour/Event to visit a particular location.
- 4.3. If the Participant cancels with less than 14 days notice, then all monies paid are forfeited.
- 4.4. If the Participant provides at least 14 days notice of a cancellation then Gourmet Pawprints may offer a transfer to another Public Tour to the same value within 90 days of the original Tour date.

5. Private Tours/Event

- 5.1. Gourmet Pawprints will advise guests if the tour is cancelled 18 hours prior to the departure time. Gourmet Pawprints will offer a transfer to an alternative date.
- 5.2. Gourmet Pawprints reserve the right to change the destination or reschedule any Tour/Event if due to circumstances beyond Gourmet Pawprints control, such as bushfire or flood, it be unsafe or impracticable for the Tour/Event to visit a particular location.

- 5.3. Gourmet Pawprints reserve the right to allow at their discretion, a mixture of both de sexed and entire dogs to participate on a Private Tour/Event.
- 5.4. The Participant acknowledges and understands that Gourmet Pawprints accepts no liability for any accident, illness or injury to any person or animal or any claim arising as a result of the participation of both de sexed and entire dogs including any accidental pregnancy resulting from contact between entire male and entire female dogs during the Private Tour/Event.
- 5.5. Tickets purchased for a Private Tour/Event cannot be transferred, and must be used for the nominated Private Tour/Event. If the Participant and the Dog cannot participate in the Tour for any reason, ticket monies will not be refunded and the Participant and Dog shall forfeit to Gourmet Pawprints all ticket monies paid.
- 5.6. Gourmet Pawprints requires a non-refundable deposit of \$500 to secure the Private Tour/Event.
- 5.7. Gourmet Pawprints requires the full monies to be paid within 30 days of the Private Tour/Event, if this has not been paid, then the deposit is forfeited and the Private/Tour/Event cancelled.

6. Gift Vouchers

- 6.1. Gourmet Pawprints offers gift vouchers which are valid
 - 6.1.1. On public tours and events only
 - 6.1.2. Valid for 6 months
 - 6.1.3. Not redeemable for cash
 - 6.1.4. Not redeemable on any Private Tour or Event
 - 6.1.5. Must be used by a Participant and Dog who adhere to the Terms and Conditions of this policy.

7. Photos/Video

- 7.1. The Participant authorises Gourmet Pawprints to use and reproduce any photos or videos of the Participant and/or the Dog taken on the Tour/Event for the purposes of the Gourmet Pawprints website, social media sites and/or any media and/or any advertising or marketing material published by Gourmet Pawprints. Should the Participant not wish to be photographed or filmed during the Tour, the Participant must notify Gourmet Pawprints prior to the commencement of the Tour and every effort will be made to exclude the Participant and the Dog from all photographs and videos taken by Gourmet Pawprints or its nominated photographer throughout the Tour.

8. Personal Information

- 8.1. The Participant acknowledges that all personal information provided by the Participant to Gourmet Pawprints will only be used for the purposes of the Tour and will not be released to any third party without the prior consent of the Participant.
